The following facts are within my personal knowledge and, if called as a witness herein, I can and will competently testify thereto.

2. Plaintiff incorporates previously filed declaration, Doc. 28.

3. During my time working as a manufacturer's representative for Schneider Electric SE, I learned that associates who stop selling for Schneider Electric SE "get slaughtered" or are "left destitute." I also inferred that there existed a malicious program for people who were identified as elite Americans. Around the time of my exit, it was made known to me that defamation is something that I should be concerned about.

4. One of the most recent events that relates to the application for a temporary restraint order filed herewith, occurred on September 14, 2023, when I walked down my street to the park and found three dogs were off-leash and they proceeded to attack me as soon as got there, while the owner yelled at me that I should stop threatening his dogs and that he is going to go get a rock and hit me with it. This man eventually wrangled his dogs and drove off, but came back a few minutes later and walked diagonally across the park to intercept me while I was jogging, I told him to leave me alone, but he stood in my path in a fighting stance with his fist clenched. He then ominously says to me, "You have been warned."

5. During this court case and since the filing of Doc. 28 events of stalking, harassment, intimidation, assaults, and verbal threats of violence have increased in intensity.

6. I believe Schneider Electric SE, its agents, assigns, partners, employees, or another individual or entity acting in concert with Defendant, will stalk, harass, assault, intimidate, and commit other crimes against me, Stanislav, Plaintiff.

7. I believe Schneider Electric SE, its agents, assigns, partners, employees, or another individual or entity acting in concert with Defendant, may attempt to cause great bodily injury or kill me.

I declare under penalty of perjury that the aforementioned is true and correct.
